SUBJECT: Program Year 2016 Workforce Innovation and Opportunity Act Allocations

Purpose

The purpose of this bulletin is to transmit Program Year (PY) 2016 allocations for programs under Title I of the Workforce Innovation and Opportunity Act (WIOA).

Background

A. Allocations

The PY 2016 allocations have been issued in accordance with the WIOA statute, the Unified State Plan, and Federal Training and Guidance Letter (TEGL) No. 17-15. State allotments are as follows:

Youth Program	\$2,139,306
Adult Program	1,825,206
Dislocated Worker Program	<u>1,894,161</u>
Total	<u>\$6,061,473</u>

B. Funds Available

The Consolidated Appropriations Act, 2016, Public Law 114-113, makes WIOA Youth Program funds available in early April 2016 and funds the WIOA Adult and Dislocated Worker Programs in two separate appropriations, continuing a practice that began with the Workforce Investment Act. The first appropriation becomes available on July 1, 2016; this portion is referred to as "base" funds. The second appropriation becomes available on October 1, 2016; this portion is referred to as "efferred to as "advance" funds.

For Program Year 2016, the Secretary of Labor is allowed to set aside up to 0.75% of the WIOA Adult, Youth, and Dislocated Worker Program allotments for the evaluation provision to build solid evidence about what works best then develop evidence-based policy and programming. Youth programs are funded through a single appropriation so the evaluation reduction is applied to the entire program year. The reduction for evaluations from the WIOA Adult and Dislocated Worker Programs will be applied to the FY 2017 "advance "funding levels; "base" funding will be disseminated at the full amount appropriated in the Act.
