### STATE CLOSING UNEMPLOYMENT AND WORKFORCE OFFICES IN KANEOHE

HONOLULU — The Hawaii State Department of Labor & Industrial Relations (DLIR) today announced that it will close the Unemployment Insurance and Workforce Development offices at the Kaneohe Atrium Building, 46-005 Kawa St. in Kaneohe on June 25, 2014. Unemployment claimants can continue to file their unemployment claims online at [uiclaims.hawaii.gov](http://uiclaims.hawaii.gov). An Unemployment Hot Line connection for Windward claimants will also be available in the Kaneohe Public Library (45-829 Kamehameha Hwy.) to obtain claim information only. Claimants may also visit the offices in Honolulu or Waipahu.
