#### **MINUTES**

Hawai'i Civil Rights Commission Office via Zoom September 19, 2023 3:00 p.m.

Chair Ebesugawa called the meeting to order at 3:02pm and noted taking agenda items out of order.

### **Chief Counsel's Report**

Chief Counsel (CC) Constance Yonashiro reported no decision yet on *Morning Hill Foods, LLC dba Mana Bu's v. The Hawai'i Civil Rights Commission*, Civil No. 18-100034-01 KKH, pending in the ICA.

CC Yonashiro gave an update on docketed cases, DN 23-01-E-SH-A-RET and DN 23-02-E-SH-RET. CC reported the docketed cases were consolidated by the hearings examiner for hearing and discovery but will have separate verdicts and judgments. Additionally, the parties stipulated to request an extension of time to hold the contested case hearing, which will be need action by the Commission. Commissioner Lewis and CC Yonashiro would be recused from any decision making. A deputy AG from the Office of the Attorney General, Chelsea Maja, will advise the Commission on any decision by the Commission in the next Commission meeting on the motion for extension of time.

CC Yonashiro provided an update on proposed changes to the Hawai'i Administrative Rules. The DLIR has requested permission from the Governor to hold a public hearing on the rules, but Governor approval might be delayed because of the Maui fires. Pending approval from the Governor, the public hearing will likely be held via Zoom towards the end of the year or early next year.

Discussion of the proposed changes of the rules took place, specifically the changes to the definition of "employment". CC explained that the HCRC currently uses a definition from a declaratory relief petition that includes factors that are numerous and confusing. The proposed definition is the same one used by unemployment insurance, temporary disability insurance, and the state's prepaid healthcare act. Having a definition in the rules, along with the proposed definition of 3 factors, which should bring clarity to the analysis. CC Yonashiro also highlighted the proposed pregnancy rule changes which aligns and borrows language from the federal Pregnant Workers' Fairness Act that took effect on June 27th of this year. Chair Ebesugawa asked if the rules had to go to the AG's for approval, and CC Yonashiro stated she believed the AG signed off on the proposed rules when the proposed rules were submitted to the Governor for approval to hold a public hearing, but will follow up with the assigned AG to determine the approval process.

### **Approval of Minutes**

Chair Ebesugawa noted that Commission Lewis joined the meeting, the Commissioners reviewed the draft minutes of the August 22, 2023 meeting. Those minutes were approved as circulated.

ED Kawatachi noted that the Annual Report will be done soon and then there could be better comparisons of the numbers for the most recent year-to-date comparisons. ED noted that consistent with his reports, looking at the data, the HCRC is coming back towards the numbers for PCQ and intake decisions that the HCRC had prior to the pandemic.

Commissioner Puette asked ED Kawatachi about the case from 2017 and asked if it was being investigated. ED Kawatachi could not provide more information other than the case was in the hands of an investigator. Chair Ebesugawa clarified that it was not that ED Kawatachi did not know the substance of the case, but that he is keeping investigation and adjudication separate, and the ED confirmed.

Chair Ebesugawa asked if there was a need to schedule the October Meeting. CC Yonashiro stated that the Commission will need to take action on a request for extension to hold a contested case hearing for the docketed cases. Next meeting of the Commission was scheduled for Tuesday, October 10th at 1:00 p.m.
