ED Kawatachi also presented a data and production report showing caseload data through March 26, 2025.

As of March 26, 2025, the written report showed 386 open cases.

Of the 386 open investigation cases, 1 (0.3%) was filed in 2017, 2 (0.5%) in 2018, 9 (2.3%) in 2019, 14 (3.6%) in 2020, 32 (8.3%) in 2021, 53 (13.7%) in 2022, 93 (24.1%) in 2023, 134 (34.7%) in 2024, and 48 (12.4%) in 2025.

ED Kawatachi reported a breakdown of the status of the open cases by type of case and investigation stage.

Update on proposed amendments to Hawai'i Administrative Rules, Title 12, Subtitle 46, Chapters 1-318:

- a. HCRC staff made additional formatting edits to the proposed rule amendments and sent a final draft to the Director of the Department of Labor and Industrial Relations (DLIR) for review.
- b. The Director of the DLIR approved the final draft, which was then transmitted to the Governor for his review.

Discussion on Legislation

HCR100 – Requesting the State of Hawai'i to require that any individual or group that administers the mandatory harassment and discrimination training to employees demonstrate adequate competency in LGBTQ+ (lesbian, gay, bisexual, transgender, queer, and more identities) identity and culturally specific gender identity relevant to Hawai'i.

Staff Recommendation: Motion to support Motion to support passed unanimously.
