As such, the parties stipulate and agree to continue the following deadlines:


- a. The position statement date from August 13, 2018 to October 12, 2018.

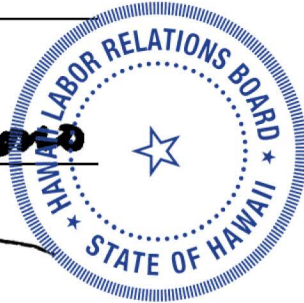
