Intervention; Notice of Scheduling Hearing on the Petition and Deadlines ("Notice of Scheduling Hearing") which scheduled a hearing on July 19, 2017 and July 20, 2017 as well as the deadline for the Application for the Issuance of Subpoenas on July 5, 2017, and the Exchange of Witness and Exhibit Lists, and to provide Copies of Exhibits to the Board on July 12, 2017;

WHEREAS, on June 30, 2017, Petitioner City and County of Honolulu ("Intervenor") advised the Board and the Complainant Hawaii Government Employees Association, AFSCME, Local 152, AFL-CIO ("HGEA") that it agreed to the transfer of certain Medical Examiner Department's Medical Investigator classes of employees in bargaining units 3 and 4 to 13;

WHEREAS, the undersigned is counsel for Intervenor; and

WHEREAS, counsel for HGEA is agreeable to continue the hearing scheduled for July 19, 2017 and July 20, 2017 and all deadlines scheduled for July 5, 2017 and July 12, 2017 for approximately sixty days; now, therefore,
