## ORDER GRANTING COMPLAINANT'S MOTION TO CONTINUE JULY 25, 2018 PREHEARING CONFERENCE

On July 9, 2019, the Hawaii Labor Relations Board (Board) issued Order No. 3376 Pretrial Order and Notices (Order No. 3376), which among other things, set a Prehearing Conference on Wednesday, June 25, 2018 at 10:00 a.m.

On July 10, 2018, Complainant HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME Local 152, AFL-CIO (Complainant) filed with the Board COMPLAINANT'S MOTION TO CONTINUE JULY 25, 2018 PRE-HEARING CONFERENCE (Motion) requesting that the scheduled Prehearing Conference be continued because Complainant's counsel had a conflict with another matter scheduled on Kaua'i. In the Motion, Complainant's counsel represented that he e-mailed counsel for Respondent STATE OF HAWAII, DEPARTMENT OF EDUCATION (DOE) to request his consent to the requested rescheduling. However, DOE's counsel declined.

Hawaii Administrative Rule § 12-42-8(g)(3)(C)(iii) allows the non-moving party Respondent DOE five days to respond to the Motion. Respondent DOE has not filed a response.

The Board HEREBY GRANTS Complainant's Motion for good cause shown and amends Sections III and VI of Order No. 3376 by changing and rescheduling the *prehearing* 

conference date to Friday, July 27, 2018 at 9:00 a.m. All other sections of Order 3376 remain in effect.
