ORDER GRANTING RESPONDENTS BERNARD P. CARVALHO, JR., DARRYL D. PERRY AND COUNTY OF KAUA'I'S MOTION TO CONTINUE HEARING (FILED 2/09/2016)

In its Notice of Hearing and Prehearing Schedule filed on February 5, 2016 (Notice), the Hawaii Labor Relations Board, among other things, notified the parties that the hearing on the merits in the above-entitled matter would be held on February 18 and 19, 2016. On February 9, 2016, Respondents Bernard P. Carvalho, Jr., Darryl D. Perry and County of Kaua'i (collectively, Respondents) filed a Motion to Continue Hearing (Motion to Continue).

In his declaration attached to the Motion to Continue, Respondents' counsel, Adam P. Roversi, represented that "both Chief Perry and Chief Contrades, the two principle witnesses for both SHOPO and the County, are scheduled to attend a statewide meeting of the Joint

Terrorism Task Force on February 18, 2016." Consequently, both Chief Perry "and Chief Contrades would be unable to appear at the currently scheduled hearing on SHOPO's Complaint." Based on the foregoing, Respondents requested that (1) the hearing on the merits be moved to March 10 and 11, 2016, and (2) "the deadline for Supplemental Briefing, Witness Lists, Exhibit Lists, and Exhibits be continued to March 4, 2016, at 4:30."

On February 9, 2016, Complainant State of Hawaii Organization of Police Officers (SHOPO) filed a Statement of No Objection to the Motion to Continue.

Based on the foregoing, the Board grants the Motion to Continue, and the Notice is hereby amended to provide:

- 1. The hearing on the merits shall be held on March 10 and 11, 2016, beginning on each day at 9:00a.m.
- 2. The Supplement Prehearing Briefs, Witness Lists, Exhibit Lists and Exhibits shall be filed with the Board by the close of business (4:30 p.m.) on **March 4, 2016**.
 - 3. In all other respects, the Notice shall remain in full force and effect.
