By letter dated March 28, 2012, Appellee's counsel, Deputy Attorney General Lawrence H. Nakano, transmitted to the Hawaii Labor Relations Board (Board) a copy of a March 26, 2011 letter from Complainant-Appellant BRIAN SANTORE (Complainant-Appellant or Santore) sent via facsimile to the Hawaii Occupational Safety and Health Division. In his letter, Santore requested a 90-day continuance "in order to get funds and representation" for the hearing in this matter. The Board was notified by Appellee's counsel that he had no objection to a 90-day continuance. The Board was also notified by Respondent-Appellee's counsel that she had no objection to a one time 90-day continuance in order for Santore to retain counsel.

Based on the foregoing, the Board grants Santore's request for a 90-day continuance in order to retain counsel.


