PRETRIAL ORDER

PRETRIAL ORDER

Pursuant to the initial conference in this matter by the Hawaii Labor Relations Board (Board) on November 13, 2013, and attended by Lawrence Nakano for Complainant and Matthew C. Shannon, Esq. for Respondent, the Board sets the following deadlines and hearing dates. IT IS HEREBY ORDERED THAT:

- 1. The deadline to file the identification of live witnesses is **December 20, 2013**. Each party shall provide a list of the names of witnesses it plans to call at trial, along with the address of each witness and the general subject to which the witness will testify, to the other party and to the Board by this date.
- 2. The discovery cutoff date when all discovery will be completed is January 24, 2014. The parties are not required to file motions to permit discovery. Discovery will be controlled by the Hawaii Rules of Civil Procedure.
- 3. The deadline for the parties to exchange exhibit lists is **February 20, 2014.** In identifying exhibits, Complainant shall use numbers and Respondent shall use the letters of the alphabet. The HIOSH investigative report, not the entire file, shall be numbered and marked as Complainant Exhibit 1. Copies of proposed exhibits shall be provided to the Board by

noon of the last business day before the hearing, as follows: two (2) sets for the Board, one (1) set each for the witness, opposing counsel and yourself, and one (1) PDF copy; which are all due by noon **February 26, 2014**.

4. Trial in this matter is scheduled for **February 27, 2014 at 9:00 a.m.** in the Board's hearing room located at 830 Punchbowl Street, Room 434, Honolulu, Hawaii, 96813. The trial may be continued by the Board until completed.

Hereafter, this Pretrial Order shall control the course of proceedings including any scheduled trial date, and may not be amended except by a request by a party with written consent of the parties and the Board, or by an order granting a motion filed with the Board.
