PRETRIAL ORDER

Pursuant to the initial conference held in this matter by the Hawaii Labor Relations Board (Board) on February 6, 2014, and attended by Doris Dvonch, Deputy Attorney General for Complainant and Stacy N.H. Miller, Esq. for Respondent, the Board sets the following deadlines and hearing dates. IT IS HEREBY ORDERED THAT:

1. The deadline to file the identification of live witnesses is **May 9, 2014**. **By this date, each party shall provide the other party and the Board with a list of the names of witnesses it plans to call at trial, along with the address of each witness and the general subject to which the witness will testify.**
2. The discovery cutoff date when all discovery will be completed is **June 10, 2014**. **The parties are not required to file motions to permit discovery. Discovery will be controlled by the Hawaii Rules of Civil Procedure.**
3. The deadline for the parties to exchange exhibit lists is **July 15, 2014**. The HIOSH investigative report, not the entire file, shall be numbered and marked as Complainant's Exhibit 1. In identifying exhibits, Complainant shall use numerical designations 1-2-3-4, etc. to identify exhibits and Respondents shall use alphabetical designations A-B-C-D-, etc. to identify its exhibits. Copies of proposed exhibits shall be provided to the Board by noon July 21, 2014 which is the last business day

before the hearing, as follows: one (1) set each for the Board, the witness, opposing counsel and yourself, and one (1) PDF copy for the Board.

3. Trial in this matter is scheduled for **July 22, 2014 at 9:00 a.m.** in the Board's hearing room located at 830 Punchbowl Street, Room 434, Honolulu, Hawaii, 96813. The trial may be continued by the Board until completed.

Hereafter, this Pretrial Order shall control the course of proceedings including any scheduled trial date, and may not be amended except by a party's request with written consent of all parties and the Board, or by an order granting a motion filed with the Board.
