**ORDER GRANTING AGREED TO MOTION TO CONTINUE
AND NOTICE OF CONTINUED MOTION HEARING**

On March 7, 2014, SOUTH PACIFIC STEEL CORP (Respondent) by and through its counsel, Rose Law Firm, a Professional Association, filed AGREED MOTION TO CONTINUE (Motion) with the Hawaii Labor Relations Board (Board) requesting to extend the filing deadlines and motions hearing date.

Pursuant to the Notice of Hearing on Motions and Deadlines dated November 26, 2013, the Hawaii Labor Relations Board ("Board") set the following deadlines and motion hearing date.

Deadline to file motions: **January 8, 2014,**

Deadline to file opposition to motions: **March 7, 2014**

Deadline to file replies: **March 21, 2014.**

Hearing on motions: **March 28, 2014 at 9:00 a.m.**

On January 8, 2014, the Director, Department of Labor and Industrial Relations (Complainant) filed COMPLAINANT DIRECTOR OF LABOR AND INDUSTRIAL RELATIONS' MOTION TO DISMISS RESPONDENT'S CONTEST. Respondent's response in opposition to the motion was due Friday, March 7, 2014.

In its Motion Respondents indicated that the parties need additional time to discuss possible settlement and request that the Board extend all deadlines by two weeks and to continue

the motions hearing to a date and time convenient for the Board. Respondents also stated that Respondent's Counsel BJ Walker Esq. had conferred with Complainant's counsel Deputy Attorney General Herbert Lau who agreed to a two week extension for all deadlines and a continuance of the hearing date.

Accordingly, for good cause shown, the Board hereby GRANTS Respondents Motion and sets the following deadlines.

Deadline to file opposition to the motion: **March 21, 2014**

Deadline to file reply: **April 4, 2014.**

NOTICE IS HEREBY GIVEN that the Board will conduct a hearing on COMPLAINANT DIRECTOR OF LABOR AND INDUSTRIAL RELATIONS' MOTION TO DISMISS RESPONDENT'S CONTEST on **Tuesday April 22, 2014 at 9:00 a.m.** in the Board's Hearing Room, Room 434, 830 Punchbowl Street, Honolulu, Hawaii.

All parties have the right to appear in person and to be represented by counsel or other representative.
