On April 3, 2014, counsel for Complainant DIRECTOR, DEPARTMENT OF LABOR AND INDUSTRIAL RELATIONS (Complainant) filed Complainant Director of Labor and Industrial Relations' Motion to Reschedule Continued Initial Conference/Settlement Conference (Motion), requesting an order from the Hawaii Labor Relations Board (Board) rescheduling the Continued Initial Conference/Settlement Conference (Conference) previously set for April 14, 2014 (at 10:00 a.m.) to a date and time in May 2014.
