PRETRIAL ORDER

PRETRIAL ORDER

Pursuant to the status conference held in this matter by the Hawaii Labor Relations Board (Board) on April 11, 2014, and attended by Herbert B.K. Lau, Deputy Attorney General for DIRECTOR, DEPARTMENT OF LABOR AND INDUSTRIAL RELATIONS (Director)-Appellee and Mark Valencia, Esq. for AOAO 250 OHUA Respondent-Appellant and by Complainant-Appellee CLINT M. LODER (Loder), pro se, by telephone, the Board sets the following deadlines and hearing date. IT IS HEREBY ORDERED THAT:

- 1. The deadline to file motions is **June 13, 2014**; the deadline for a response is **June 27, 2014** and the deadline to file a Reply is **July 10, 2014**.
- 2. The deadline to file the identification of live witnesses is June 13, 2014. By this date, each party shall provide the other party and the Board with a list of the names of witnesses it plans to call at trial, along with the address of each witness and the general subject to which the witness will testify.

- 3. The discovery cutoff date when all discovery will be completed is July 11 2014. The parties are not required to file motions to permit discovery. Discovery will be controlled by the Hawaii Rules of Civil Procedure.
- 4. The deadline for the parties to exchange exhibit lists is **August 5**, **2014.** The HIOSH investigative report shall be numbered and marked as DLIR Exhibit 1. In identifying exhibits, Director-Appellee shall use numbers, 1-2-3-4, etc., Complainant-Appellee Loder shall use Roman Numerals, I, II, III, IV, etc. and Respondent-Appellant AOAO 250 OHUA shall use letters of the alphabet, A-B-C-D, etc. Copies of proposed exhibits shall be provided to the Board by noon of the last business day before the hearing, which is August 11, 2014, as follows: one (1) set each for the Board, one (1) set each for the witness, opposing counsel and yourself, and one (1) PDF copy.
- 5. Trial in this matter is scheduled for **August 12, 13, and 14, 2014 at 9:00 a.m.** in the Board's hearing room located at 830 Punchbowl Street, Room 434, Honolulu, Hawaii, 96813. The trial may be continued by the Board until completed.

Hereafter, this Pretrial Order shall control the course of proceedings including any scheduled trial date, and may not be amended except by a party's request with written consent of all parties and the Board, or by an order granting a motion filed with the Board.
