STIPULATION TO WITHDRAW CITATION ISSUED ON FEBRUARY 19, 2013

This Stipulation to Withdraw Citation Issued on February 19, 2013, hereinafter referred to as "Stipulation") entered into by and between Complainant DIRECTOR, DEPARTMENT OF LABOR AND INDUSTRIAL RELATIONS, (hereinafter referred to as "Director") and Respondent MUNDEN DESIGN & BUILD (hereinafter referred to as "Respondent") whose business address is 59-748 Amaumau Place, Haleiwa, Hawaii 96712; and WHEREAS, on or about November 15, 2012, the Director, by and through the

State of Hawaii's Occupational Safety and Health Division ("HIOSH"), inspected a worksite located at 61-216 Kamehemeha Highway, Haleiwa, Hawaii, 96712;

WHEREAS, as a consequence of said inspection, the Director, through HIOSH's Administrator, issued a Citation and Notification of Penalty ("Citation") on February 19, 2013 to the Respondent alleging a violation of the Hawaii Occupational Safety and Health Standards and assessed a penalties totaling \$1,155.00, a copy of which is attached as Exhibit A; and .

WHEREAS, Respondent timely contested the Citation; and.

WHEREAS the parties hereto wish to avoid the expense of litigation and to compromise and settle the above-captioned case; and

NOW THEREFORE the parties, by and through their respective representatives, stipulate and agree as follows:

- 1. The Hawaii Labor Relations Board has jurisdiction over this contested case pursuant to Section 396-11, Hawaii Revised Statutes ("HRS").
- 2. The Citation issued on February 19, 2013 against Respondent, including penalties totaling \$1,155.00, is withdrawn.
 - 3. This Stipulation shall become a final order of the Director.
- 4. In consideration of the Director's withdrawal of the citation issued on February 19, 2013, Respondent, and its predecessors, parent corporations, holding companies, subsidiaries, affiliates, divisions, heirs, successors and assigns, and all of their officers, directors and employees, hereby release, waive, cancel, forgive and forever discharge any and all actions, claims, demands, damages, obligations, liabilities, controversies and executions, of any kind or nature whatsoever, whether known or unknown, whether suspected or not, which have arisen, or may have arisen, or shall arise against the Director or any of his employees or representatives,

relating to or resulting from the Inspection conducted on November 15, 2012 at the worksite located at 61-216 Kamehemeha Highway, Haleiwa, Hawaii, 96712, and/or the citation issued on February 19, 2013.

Upon approval of this Stipulation, all proceedings before the Board shall 5. be dismissed.
