SET FOR JULY 28, 2014; AND NOTICE OF STATUS CONFERENCE

On July 14, 2014, Respondent PROTECH ROOFING, LLC (Respondent), by and through its attorney, filed Respondent PROTECH Roofing, LLC's Motion to Withdraw Motion to Vacate An[d] Request for Trial (Motion). Respondent's Motion included a withdrawal of its Motion to Vacate filed with the Hawaii Labor Relations Board (Board) on June 30, 2014; a request for trial date and other deadlines deemed necessary by the Board; and a request that the hearing on Respondent's Motion to Vacate, scheduled for July 28¹, 2014, be cancelled and a status conference scheduled instead.

Accordingly, the Board hereby grants Respondent's Motion and cancels the motion hearing scheduled for July 28, 2014. The Board also denies as moot Complainant's Motion to Continue Hearing Set for July 28, 2014, filed on July 3, 2014.

NOTICE IS HEREBY GIVEN, that the Board will conduct a Status Conference on Tuesday, August 5, 2014 at 9:00 a.m., HST, in the Board's Hearing Room, Room 434, 830 Punchbowl Street, Honolulu, Hawaii. The purpose of the Status Conference is (1) to establish trial dates and deadlines, and (2) to discuss other procedural matters.

All parties have the right to appear in person and to be represented by counsel or other representative.
