On July 15, 2014, Respondent, Hale Mahaolu, (Respondent) through its attorney Lisa Bail, Esq. (Ms. Bail), filed Respondent's Motion to Continue Status Conference Set for July 18, 2014 (Motion), with the Hawaii Labor Relations Board (Board) in accordance with Hawaii Administrative Rules (HAR) §12-42-8(g)(3)(C) and based on the Memorandum in Support of Motion and the record and files in this case.

In the Memorandum In Support of Motion, attached to the Motion, Respondent made the following statements: (1) Hale Mahaolu and Counsel for the Director (the "Parties") need additional time to evaluate the case and narrow issues for trial; (2) continuing the status conference will enable the Parties to continue their existing dialogue and explore alternative resolution prior to setting a trial date; and (3) the parties are in agreement that they would benefit from continuing the July 18, 2014 status conference to a time on or after September 15, 2014.

No opposition was filed with the Board.

Pursuant to the Respondent's request and in view of the facts presented as stated above, the Board rules on this matter without a hearing. The Motion is granted; the previously scheduled status conference is continued and re-scheduled accordingly.
