On August 18, 2014, the Hawaii Labor Relations Board (Board) issued a Notice of Initial Conference/Settlement Conference (Notice) for the above-entitled case. The Notice informed the parties that the Board will conduct an initial conference/settlement conference (Conference) on Tuesday, September 2, 2014 at 9:00 a.m. on all matters related to this case.

On August 19, 2014, the DIRECTOR OF LABOR AND INDUSTRIAL RELATIONS (Complainant) by and through his attorney, Doris Dvonch, Deputy Attorney General, filed COMPLAINANT DIRECTOR OF LABOR AND INDUSTRIAL RELATIONS' MOTION TO CONTINUE INITIAL CONFERENCE/SETTLEMENT CONFERENCE (Motion) with the Board on the grounds that Complainant's counsel was not available to attend the September 2, 2014 Conference. The Motion was accompanied by a declaration from Complainant's counsel stating that she conferred with Respondent and that Respondent is amenable to continuing the Conference.

Accordingly, for good cause shown, the Board hereby GRANTS the Motion. The Conference scheduled for September 2, 2014 has been taken off the calendar.


NOTICE OF CONTINUED INITIAL
