On September 3, 2014 the Hawaii Labor Relations Board (Board) issued Board Order No. 594 Granting the DIRECTOR OF LABOR AND INDUSTRIAL RELATIONS' Motion to Reschedule Initial Conference/Settlement Conference and Notice of Initial Conference/Settlement Conference informing the parties that the Board will conduct an Initial Conference/Settlement Conference (Conference) on December 17, 2014 at 9:00 a.m.
