CONTINUE DISCOVERY DEADLINE AND MOVE TRIAL

By Order No. 597, Pretrial Order, filed September 10, 2014, the Hawaii Labor Relations Board (Board) established discovery deadlines, including the discovery cutoff date of December 29, 2014, and the hearing date of January 29, 2015 in the above-captioned matter. On December 15, 2014, counsel for the Complainant, DIRECTOR OF LABOR AND INDUSTRIAL RELATIONS (Director), filed the Director's Motion to Continue Discovery Deadline and Move Trial (Motion) in which the Director requested that the Board order a continuance of the December 29, 2014 discovery deadline from December 29, 2014 to January 23, 2015. Counsel for Complainant Director declared that both the Director and

Respondent PROTECH ROOFING, LLC agreed to continue the discovery deadline as requested to complete discovery.

Although the caption of the Director's Motion indicates that the Director requests the scheduled trial date be moved also, there is no reference in the motion itself to said request or written consent of the parties to do so.


Therefore, pursuant to the Director's request with the mutual agreement of the parties, the Director's motion to continue the discovery cutoff deadline from December 29, 2014 to January 23, 2015 is granted. The Director's Motion to move trial currently set for January 29, 2015 is denied.

ORDER


