On May 19, 2015, counsel for STATE OF HAWAII, DEPARTMENT OF HEALTH-HAWAII STATE HOSPITAL, Respondent, filed a non-hearing motion at the Hawaii Labor Relations Board (Board), Respondent's Motion to Reschedule Initial Conference/Settlement Conference, scheduled for May 28, 2015, to a date during the month of July 2015 because of a scheduling conflict with a Family Court matter and to allow the parties additional time to explore possible settlement of this case. On May 20, 2015, counsel for DIRECTOR, DEPARTMENT OF LABOR AND INDUSTRIAL RELATIONS, Complainant, filed Complainant Director of Labor and Industrial Relations' Statement of No Objection to Respondent State of Hawaii, Department of Health-Hawaii State Hospital's Motion to Reschedule Initial Conference/Settlement Conference (Motion).

Accordingly, for good cause shown, and there being no objection to Respondent's non-hearing Motion, the Board hereby GRANTS the Motion. The Initial Conference/Settlement Conference (Conference) scheduled on May 28, 2015, has been taken off the Board's calendar. For the record, the Board notes that matter has been continued by Board order at the parties' request three times previously beginning on September 3, 2014.


