This action is deemed closed.



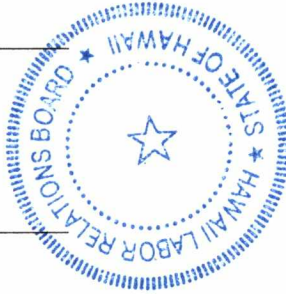
