STIPULATION TO CONTINUE INITIAL CONFERENCE

WHEREAS, on June 30, 2016, the Notice of Initial Conference ("Notice") was issued by the Hawaii Labor Relations Board, informing the parties that an initial conference will be held on Thursday, July 14, 2016;

WHEREAS, counsels for the parties have been actively communicating with each other for the purpose of ultimately arriving at a settlement of this contested case;

WHEREAS, the instant contested case is a complex case and arises out of an

industrial accident involving other utility companies. A civil suit has arisen out of this incident which, at the present time, prevents the Director from interviewing several witnesses from Hawaii Gas in order to assess its case for purposes of settlement. The Director is attempting to interview these witnesses but will need further time because of the pending civil litigation.

WHEREAS, the undersigned counsel for the Director sought and obtained Respondent's counsel's consent for a continuance of the initial conference currently scheduled for July 14, 2016.

THEREFORE, IT IS HEREBY STIPULATED by and between the DIRECTOR, DEPARTMENT OF LABOR AND INDUSTRIAL RELATIONS and ROAD BUILDERS CORPORATION, by and through their respective counsels, to continue the initial conference of July 14, 2016, to October 14, 2016, or any other date the Labor Relations Board designates.


This stipulation is not submitted for the purpose of delay but for the purpose of pursuing settlement of the contested case.



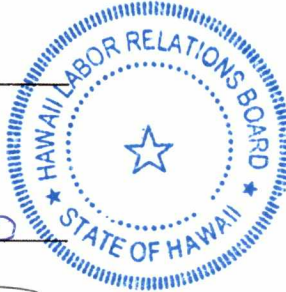
