# ORDER GRANTING COMPLAINANT DIRECTOR OF LABOR AND INDUSTRIAL RELATIONS' MOTION TO CONTINUE TRIAL

On September 19, 2016, the Hawaii Labor Relations Board (Board) received correspondence from counsel for Complainant Director, Department of Labor and Industrial Relations (Complainant), notifying the Board of circumstances that warrant a postponement of the trial in this matter previously scheduled for October 3, 2016. Representative for Respondent Hawaii Solar & Wind, LLC (Respondent), was copied on the correspondence.

On September 20, 2016, Complainant filed a Motion to Continue Trial (Motion), requesting a continued hearing date of October 26, 2016, on the grounds that the parties are in the process of settling the contested case.

Due to the short time until the previously scheduled trial date, the Board hereby GRANTS Complainant's Motion without waiting for Respondent's time to oppose the motion to run. However, should Respondent subsequently file an opposition to the Motion, the Board will reconsider its granting of Complainant's Motion.
