ORDER GRANTING RESPONDENT-APPELLANT'S MOTION TO CONTINUE HEARING

On January 24, 2017, RESPONDENT-APPELLANT, by and through its counsel, Austin F. McCullough, Esq. (McCullough), filed Respondent-Appellant's Motion to Continue hearing (Motion). In his Declaration attached to the motion, McCullough represented that all the parties are in agreement with this motion. He also requested that the Hearing and Prehearing Submission's dates be continued for four weeks or by agreement of all parties.

All other unaffected provisions of the Board's Notice of Continued Hearing issued on November 30, 2016 remain in effect.
