**STIPULATION TO REMAND AND DISMISSAL OF APPEAL**


IT IS HEREBY STIPULATED AND AGREED by and between Complainant-Appellant SANDRA ROBERTS, Respondent Appellee THE ARC IN HAWAII, by and through its attorney Wesley M. Fujimoto and Appellee DIRECTOR OF DEPARTMENT OF LABOR AND INDUSTRIAL RELATIONS, by and through her attorney, Amy Chan, Deputy Attorney General, that this case be remanded back to the State of Hawaii Department of Labor and Industrial

Relations, Hawaii Occupational Safety and Health Division ("HIOSH") for further investigation into Complainant-Appellant's discrimination complaint dated June 27, 2016.

IT IS FURTHER HEREBY STIPUATED AND AGREED by the parties that this Board shall dismiss and close this appeal. Upon completion of the investigation, HIOSH shall issue a new Determination Notice and Order ("DNO") to SANDRA ROBERTS and THE ARC IN HAWAII regarding Complainant-Appellant's discrimination complaint dated June 27, 2016. If a party is dissatisfied with that DNO, an appeal may be filed pursuant to Hawaii Revised Statutes § 396-11.
