THIRD STIPULATION TO CONTINUE STATUS LETTER DUE DATE

WHEREAS, on May 12, 2016, the Hawaii Labor Relations Board issued a Notice  
of Case Assignment requiring each party to submit a Status Letter on July 25, 2016;

WHEREAS, on July 25, 2016, the parties submitted a Stipulation to Continue  
Status Letter Due Date, continuing the due date to October 25, 2016;

WHEREAS, on October 25, 2016, the Labor Board approved a Second Stipulation to Continue Status Letter Due Date, continuing the due date to December 28, 2016;

WHEREAS, on December 21, 2016, the Labor Board approved a Third Stipulation to Continue Status Letter Due Date, continuing the due date to December 28, 2016;

WHEREAS, the parties have entered into a settlement in principle and are negotiating the ancillary terms of the settlement agreement;

WHEREAS, the parties anticipate to reach a final settlement agreement within a month, and hence, both parties agree to a further continuation of the status letter due date;

THEREFORE, IT IS HEREBY STIPULATED by and between the DIRECTOR, DEPARTMENT OF LABOR AND INDUSTRIAL RELATIONS and ISLAND PACIFIC ENERGY, LLC, by and through their respective counsels, to continue the Status Letter due date of February 13, 2017 to March 13, 2017, or any other date the Labor Relations Board designates.

This stipulation is not submitted for the purpose of delay.

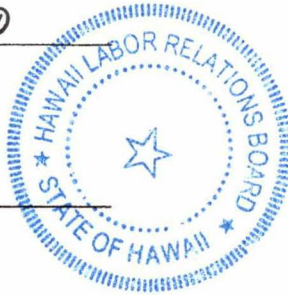
