STIPULATION TO CONTINUE

Complainant Director of Labor and Industrial Relations, by and through her attorney,
Amy Chan, Deputy Attorney General, and Respondent Covanta Honolulu Resource Recovery
Venture LLC, by and through its attorney, Darin Leong, stipulate and agree to continue the
Position Statement, Status Conference, De Novo Hearing, and all other deadlines for two
