## ORDER REJECTING PETITION FOR DECLARATORY RULING

On May 11, 2000, Petitioner LEWIS W. POE (POE) filed the instant Petition for Declaratory Ruling using a form furnished by the Hawaii Labor Relations Board (Board) pursuant to Administrative Rules § 12-42-9(b). Administrative Rules § 12-42-9 provides, in part, that:

- (c) The petition shall contain the following:
  - (1) The name, address, and telephone number of the petitioner.
  - (2) A statement of the nature of the petitioner's interest, including reasons for submission of the petition.
  - (3) A designation of the specific provision, rule, or order in question.
  - (4) A clear and concise statement of the position or contention of the petitioner.
  - (5) A memorandum of authorities, containing a full discussion of the reasons, including legal authorities, in support of such position or contention.
  - (6) The signature of each petitioner.
- (d) Any petition which does not conform to the foregoing requirements may be rejected.

After reviewing POE's petition, the Board finds that:

1. POE states in Paragraph 3 of the petition that "Poe is an interested person." There is no clear "statement of the

nature of the petitioner's interest," required under Administrative Rules § 12-42-9(c)(2).

- 2. POE states in Paragraph 3 of the petition that "Poe needs clarification on several aspects of the provisions of Ch. 89, HRS," and poses the following question: "What's the purpose of the GP (Grievance Procedure)?" The petition does not adequately explain "the reasons for the submission of the Petition," required under Administrative Rules § 12-42-9(c)(2).
- 3. A reading of the petition form in its entirety, fails to provide a "clear and concise statement of the position or contention of the petitioner," required under Administrative Rules § 12-42-9(c)(4).
- 4. There is no "memorandum of authorities, containing a full discussion of the reasons, including legal authorities, in support of such position or contention" attached to the petition as required under Administrative Rules § 12-42-9(c)(5).

Thus, pursuant to Administrative Rules § 12-42-9(d), the Board hereby rejects POE's petition for failing to conform to the requirements outlined above. This rejection does not preclude petitioner from conforming to the requirements and submitting a new petition with the Board.
