ORDER GRANTING MOTION TO WITHDRAW PROHIBITED PRACTICE COMPLAINT

On September 16, 2018, Complainant LENORA L. ASATO (Complainant or Asato), self-represented litigant, filed a prohibited practice complaint (PPC) against Respondent HAWAI'I GOVERNMENT EMPLOYEES ASSOCIATION (Respondent or HGEA) in Case No. 18-CU-08-366 with the Hawaii Labor Relations Board (Board). The Board subsequently filed a Pretrial Order No. 3396 and Notices on September 18, 2018.

On September 24, 2018 Respondent filed HGEA/AFSCME'S MOTION FOR PARTICULARIZATION OF THE COMPLAINT FILED ON SEPTEMBER 16, 2018 (Motion for Particularization).

On October 3, 2018, the Board conducted a Prehearing/Settlement Conference, at which the Parties orally stipulated to allow Asato to file an amended complaint in lieu of particularization on or about October 17, 2018.

On October 17, 2018, Complainant filed LENORA L. ASATO'S MOTION FOR WITHDRAWAL WITHOUT PREJUDICE FOR COMPLAINT FILED ON SEPTEMBER 16, 2018 (Motion to Withdraw). Subsequently, Respondent filed HGEA/[AFSCME]'S

MEMORANDUM IN OPPOSITION TO COMPLAINANT'S MOTION TO WITHDRAW PROHIBITED PRACTICE COMPLAINT FILED ON SEPTEMBER 16, 2018 (Opposition to Motion to Withdraw).

On October 26, 2018, the Board began the hearing on the merits of the PPC. The Board then allowed the Parties to present oral arguments on the Motion to Withdraw.

Under HAR § 12-42-44, "[a]ny complaint may be withdrawn at any time prior to the issuance of a final order thereon, upon motion and with the consent of the board. Whenever the board approves withdrawal of such complaint, the case shall be closed."

Based on a review of the full record, the Board grants the withdrawal of the PPC. This case is closed.
