ORDER GRANTING MOTION TO EXTEND TIME TO FILE ANSWERING AFFIDAVITS AND TO FILE RESPONDENT FRANK F. FASI'S MOTIONS

On January 27, 1987, Complainant EDGAR H. W. LUM, by and through his attorneys, filed a Motion to Vacate Arbitration Decision and Award with this Board. Thereafter on January 29, 1987, Respondent Frank F. Fasi, Mayor of the City and County of Honolulu, successor to EILEEN R. ANDERSON, former Mayor of the City and County of Honolulu, by and through his attorneys, filed a Motion to Extend Time to File Answering Affidavits and to File Respondent Frank F. Fasi's Motions. The affidavit of Burt T. Lau attached to the instant motion indicates that he requests the time deadline for response to be extended from February 3, 1987 to and including February 17, 1987 in order to permit the Respondent to file a motion to dismiss. The affiant indicates that he requested a continuance from Complainant's counsel but his requests were denied.

On February 2, 1987, Complainant, by and through his attorneys, filed an Answering Affidavit of Ronald T. Fujiwara. The affidavit states that the Board's Administrative Rules does not permit an extension of time to raise jurisdictional issues by way of a motion to dismiss and that such issues should be properly raised in an answering affidavit. Moreover, affiant does not believe that a two-week extension is required and thus, is agreeable to an extension of time up to and including February 6, 1987.

In order to receive a full discussion of relevant legal arguments, the Board hereby grants Respondent's motion for extension of time. Respondent is hereby directed to file any answering affidavits or appropriate motions by 4:30 p.m., February 17, 1987.
