On March 8, 1988, at a hearing held in this matter counsel for the HAWAII TEAMSTERS & ALLIED WORKERS, LOCAL 996, INTERNATIONAL BROTHERHOOD OF TEAMSTERS [hereinafter referred to as TEAMSTERS] indicated that the parties had reached a settlement in this case. Hence, counsel for TEAMSTERS made an oral motion to withdraw its Statement of Objections to the Conduct of Election or Conduct Affecting the Results of an Election. The other parties present indicated no objections to such withdrawal.

A representation proceeding having been conducted pursuant to the Direction of Election, issued on September 18, 1987, the Amended Direction of Election, issued on September 21, 1987 and the Second Amended Direction of Election, issued on Ocrober 3, 1987, by the Board in accordance with Chapter 89, Hawaii Revised Statutes [hereinafter referred to as HRS] and its Administrative Rules, and it appearing that an exclusive representative has been selected; pursuant to the authority vested in the Board by Chapter 89, HRS:

IT IS HEREBY CERTIFIED THAT the UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO shall continue in its designation and selection by the majority of nonprofessional hospital and institutional workers in the appropriate bargaining unit described below, as the exclusive bargaining representative for the purpose of bargaining collectively on questions of wages, hours and other terms and conditions of employment.

VOTING UNIT

Unit 10 includes all employees classified as supervisory and nonsupervisory Nonprofessional Hospital and Institutional Workers, including:

All supervisory and nonsupervisory hospital and institutional workers, including Licensed Practical Nurses, Adult Corrections Officers II through Lieutenants, Houseparents, Juvenile Detention Officers, Paramedical Assistants, School Dormitory Attendants, Morgue Attendants, Central Supply Aides, Respiratory Therapy Technicians III's, IV's and V's, Occupational Therapy Assistants, Youth Corrections Officers, Institution Sewing Instructors, Institution Carpentry

Instructors, Emergency Medical Technicians II's through V's, Ambulance Service Support Technicians, Health Services Assistants and Prosector Assistants.
