FINDINGS OF FACT, CONCLUSIONS
OF LAW AND ORDERS

On June 1, 1979, the Board of Regents of the University of Hawaii petitioned this Board for the transfer of two positions from Unit 4 to Unit 8 and one position from Unit 8 to Unit 7.

Based upon the petition, the Affidavit of the University's Director of Administration Harold S. Masumoto, and the current position descriptions supplied by Mr. Masumoto for the positions in question, the Board makes the following:

FINDINGS OF FACT

The Board of Regents (hereafter BOR) is a public employer of employees in Units 7 and 8.

The Hawaii Government Employees' Association (hereafter HGEA) is the exclusive representative of employees in Units 4 and 8 and the University of Hawaii Professional Assembly (hereafter UHPA) is the exclusive representative of Unit 7.

The HGEA and UHPA concur in the transfer of the subject positions proposed by the BOR and waive a hearing thereon.

The positions in question are:

Position No. 00847, Data Processing Unit Supervisor I (incumbent Grace O. Miji), presently a Unit 4 position; Position No. 07905, Data Processing Unit Supervisor II (incumbent Edwin Kalai), presently a Unit 4 position; and Position 80406, UH Research Associate IV (incumbent John J. Cho), currently a Unit 8 position.

The BOR intends to reclassify the two Unit 4 positions as Unit 8 positions and the Unit 8 position as a Unit 7 position.

The duties and responsibilities of the position are stated in current position descriptions. The position descriptions have been certified to be accurate by the supervisors and incumbents of the positions.

CONCLUSIONS OF LAW

The BOR by competent evidence has established that the proposed unit changes for the three positions are proper.

ORDERS

Position Nos. 00847 and 07905 are transferred from Unit 4 to Unit 8.

Position No. 80406 is transferred from Unit 8 to
Unit 7.

The mechanics of the transfers shall be worked out
among the parties to this case, provided that the effective
date shall not be earlier than the date of this decision.
