CERTIFICATION OF EXCLUSIVE BARGAINING REPRESENTATIVE AND ORDER
TO NEGOTIATE

A representation proceeding having been conducted pursuant to Stipulations for Election in the above entitled matter by the Public Employment Relations Board in accordance with the Hawaii Public Employment Relations Act and the Rules of Procedure of the Board, and it appearing that an exclusive bargaining representative has been selected; pursuant to the authority vested in the Board by the Hawaii Public Employment Relations Act, IT IS HEREBY CERTIFIED that the HAWAII GOVERNMENT EMPLOYEES' ASSOCIATION, LOCAL 152, (AFSCME/AFL-CIO) has been designated and selected by a majority of the supervisory employees in white collar positions of the above-named public employers, in the appropriate bargaining unit described herein, as their exclusive bargaining representative, effective May 3, 1972, for the purpose of bargaining collectively on questions of wages, hours, and other terms and conditions of employment.

UNIT:

Included: All SUPERVISORY employees in white collar positions employed by the State of Hawaii, City and County of Honolulu, and the Counties of Hawaii, Maui, and Kauai, except those determined not to be eligible to vote.

Excluded: Employees determined to be top-level managerial and/or administrative by the Public Employment Relations Board; all elected officials, members of any board or commission, part-time employees working fewer than twenty (20) hours per week, temporary employees of three months duration or less; confidential employees; and employees who normally would belong to this unit but who were not eligible to vote because their work is confidential in nature and certain other excluded employees as listed herewith:
