#### DISSENTING OPINION

I dissent from the determination of my two colleagues, whereby they deny some 450 to 500 more or less, non-supervisory white collar employees (clerks, typists, stenographers and secretaries) their right to be represented. By excluding them from the non-supervisory white collar bargaining unit, on the allegation that they are concerned with confidential employee-employer relation matters. These exclusions are made with no evidence in the record to justify their exclusions. I cannot accept the employer-union stipulation that this great number of excluded non-supervisory employees are individuals concerned with confidential matters affecting employee-employer relations and should be excluded. I cannot believe that the Legislature intended to deny great numbers of non-supervisory white collar employees their legal right to be represented by a union (employee organization) of their choice, or their right to participate in its selection. If the Legislature had so intended it would have said so. It did not say so. It said the opposite.

When the Legislature used the language: "No...individual concerned with confidential matters affecting employee-employer relations... shall be included in any appropriate bargaining unit or entitled to coverage under this Chapter." In my judgment, the Legislature did not intend that non-supervisory employees who might have some, at most casual involvement and/or contact with employee-employer relations would be excluded from their appropriate bargaining unit.

According to Webster's Collegiate Dictionary, the word "concerned" implies the bearing or influence, having affect, the direct operation or action, of one thing on another, that which relates or belongs to one.

The occasional typing of a supervisor's reprimand and filing it in the employee's folder, time and attendance record keeping, etc., is no more than <u>casual</u> contact with and cannot be construed as being <u>concerned</u> enough with employee-employer relations to deny the typist or secretary her right to be represented and to have the protection and services of her union.

Based on the foregoing, I cannot agree with my colleagues' decision excluding great numbers of non-supervisory white collar employees. In my judgment there is little if any justification for their exclusion.
