## ORDER GRANTING COMPLAINANT'S REQUEST TO CONTINUE HEARING; NOTICE OF STATUS CONFERENCE; AND NOTICE OF RESCHEDULED HEARING

On August 26, 2003, at the hearing on Respondents' respective motions to dismiss or for summary judgment and the merits of this case, Complainant J. TEK YOON (YOON), pro se, requested a continuance to obtain counsel because he had received a letter from Ted H.S. Hong, Esq., dated August 22, 2003, stating that he would not represent Complainant. In addition, YOON stated he needed legal representation because he has also since been terminated.

Counsel for the respective Respondents objected to any further continuances because, <u>inter alia</u>, the matter had already been continued from May 7, 2003 upon YOON's representation that the continuance was necessary to accommodate his work schedule and his attorney (who he refused to name) was unavailable. Counsel argued that they were prejudiced because of the lost resources in preparing for the hearing in reliance upon the representation that the matter would not be continued.

For good cause shown, the Hawaii Labor Relations Board (Board) grants Complainant a 30-day continuance of the hearing on the pending motions and on the merits of his complaint.

NOTICE IS HEREBY GIVEN that the Board will conduct a status conference on September 26, 2003 at 9:00 a.m. in the Board's hearing room, Room 434, 830 Punchbowl Street, Honolulu, Hawaii.

NOTICE IS ALSO GIVEN that the hearing on Respondent Department of Parks and Recreation, City and County of Honolulu's Motion to Dismiss Complaint filed on April 10, 2003, Respondent Hawaii Government Employees Association, AFSCME, Local 152, AFL-CIO's Motion for Summary Judgment filed on August 21, 2003, and thereafter, the hearing on the merits of the instant complaint, if necessary, is rescheduled until September 29, 2003 at 9:30 a.m. in the Board's hearing room. The hearing will continue from day to day until completed.
