ORDER GRANTING COMPLAINANT'S MOTION TO WITHDRAW COMPLAINT, FILED ON JANUARY 27, 2006

On January 27, 2006, Complainant, by and through its counsel, filed a motion to withdraw the instant complaint with the Hawaii Labor Relations Board (Board). Complainant's counsel requested the withdrawal of the complaint based on a Settlement Agreement dated January 25, 2006, regarding UPW Local 646 and State, Dept. of Public Safety - Refusal to permit stewards and officers to participate in meetings and predisciplinary hearings - Case No. CE-10-592, Our file no. 2005-038, attached as Exhibit A to its motion. Complainant noted in footnote 1, that while the Settlement Agreement refers to Case No. CE-10-592, the intent of the settlement agreement is to resolve the instant case. Thereafter, on January 31, 2006, Complainant submitted a Supplemental Submission with an Amended Settlement Agreement, dated January 27, 2006 attached as Exhibit B which refers to Case Nos. CE-10-592 and CE-10-601.

Also on January 31, 2006, Respondents, by and through their counsel, filed a Notice of No Objection to UPW's Motion to Withdraw Complaint noting its agreement that the intent of the settlement agreement for Case No. CE-10-502 is to resolve this case.

After reviewing the record and the instant motion, the Board finds that the issues underlying the complaint have been resolved and hereby grants Complainant's Motion to Withdraw Complaint pursuant to Hawaii Administrative Rules (HAR) § 12-42-44.
