## ORDER DECLARING AN IMPASSE AND APPOINTING A MEDIATOR

On September 15, 2006, the HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO ("HGEA"), by and through its representative, filed a written notification with the Hawaii Labor Relations Board ("Board") that negotiations over a collective bargaining agreement for employees in bargaining unit 02 (Supervisory employees in blue collar positions), 04 (Supervisory employees in white collar positions), 06 (Educational officers and other personnel of the department of education under the same salary schedule), 08 (Personnel of the University of Hawaii and community college system, other than faculty) and 13 (Professional and scientific employees, who cannot be included in any of the other bargaining units) commenced on May 10, 2006 and an impasse has been reached in contract negotiations. Pursuant to Hawaii Revised Statutes § 89-11(c), September 15, 2006 is the date of impasse.

To assist the parties, the Board has asked the Federal Mediation and Conciliation Service to provide a mediator to assist the parties in the voluntary resolution of their dispute. Federal Mediator Ken Kawamoto has agreed to serve and is hereby appointed as mediator in the instant impasse.
