By letter dated February 20, 2009, Complainant's counsel informed the Hawaii Labor Relations Board (Board) that Respondent's counsel consented to a request to extend the deadline to file a memorandum in opposition to Complainant's Motion to Dismiss Complaint Filed January 29, 2009, filed on February 12, 2009 (Motion to Dismiss Complaint) in order to consult with Complainant's business agent who was unavailable. NOTICE IS ALSO GIVEN that the hearing on the merits of the complaint previously scheduled on March 3, 2009 is continued until further noticed. The Board, pursuant to HRS §§ 89-5(i)(4) and (i)(5) and 89-14, and HAR § 12-42-8(g), will conduct a hearing on Respondent's Motion to Dismiss Complaint on March 17, 2009 at 8:30 a.m. in the above-referenced hearing room.

Appropriate provisions of the Notice of Prehearing/Settlement Conference; and Notice of Hearing on Prohibited Practice Complaint, dated February 13, 2009, remain applicable.
