ORDER APPOINTING CHAIR OF ARBITRATION PANEL AND CERTIFYING APPOINTMENT OF PANEL

On March 3, 2009, the United Public Workers, AFSCME, Local 646, AFL-CIO (UPW), and the State of Hawaii, the Judiciary, the Hawaii Health Systems Corporation, and the City and County of Honolulu, parties to the Unit 10 collective bargaining agreement, entered into a Memorandum of Agreement (MOA) setting forth an alternative impasse procedure for Unit 10 pursuant to Hawaii Revised Statutes (HRS) § 89-11(a).

By letter dated June 29, 2009, Herbert R. Takahashi, Esq., on behalf of Dayton Nakanelua who is the union representative pursuant to the MOA, advised the Board Chair that pursuant to the June 23, 2009, letter regarding "Submission of Impasse to Arbitration," Clifford Uwaine would serve as the Union's panel member. By letter dated July 29, 2009, Marie Laderta, who is the employer representative pursuant to the MOA, informed the Board Chair that the State had selected Stanley Shiraki to serve as the employer panelist for the UPW Unit 10 arbitration hearing.

By letter dated September 30, 2009, and received by the Board via e-mail transmittal on September 30, 2009, Chris Camardella (Camardella), Case Manager, American Arbitration Association (AAA), notified the parties that, in accordance with Board Order No. 2640, Jonathan Dworkin has been appointed arbitrator in this matter.²

Based on the foregoing, the Board hereby appoints Jonathan Dworkin to serve as the neutral arbitrator and chair of the arbitration panel to which the parties shall submit their complete final offers as provided in HRS § 89-11(e), as modified by their mutually agreed upon Alternate Impasse Procedure, as amended, if not already done. The Board also certifies Clifford Uwaine and Stanley Shiraki as members of the panel. The panel shall have such authority and duties as conferred by law.
