ORDER GRANTING UPW'S MOTION TO EXTEND DEADLINE AND HEARING DATE ON RESPONDENTS' MOTION FOR SUMMARY JUDGMENT; AND NOTICE OF HEARING ON MOTIONS

On October 13, 2009, Complainant UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO (UPW or Union), by and through its counsel, filed a Motion to Extend Deadline and Hearing Date on Respondents' Motion for Summary Judgment with the Hawaii Labor Relations Board (Board). Complainant requested the Board to extend the deadline for the UPW's opposition to Respondents' Motion for Summary Judgment filed on October 12, 2009 until after a hearing and/or disposition of three pending motions, i.e., 1) a September 23, 2009 motion to consolidate cases for the purposes of hearings and contemporaneous consideration filed by the Union; 2) an October 5, 2009 motion to enforce subpoena duces tecums of Elizabeth Char, Donnie Gates, and Keala Watson filed by the Union, and an October 12, 2009 motion to quash discovery requests filed by Respondents. Complainant's counsel states in an affidavit attached to the motion that it intends to oppose the motion for summary judgment but that it would make logical sense to have discovery and procedural matters resolved before submitting an opposition to the motion for summary judgment and further, that Respondents' counsel agreed to the extension of time.

Based on the foregoing, for good cause shown, the Board hereby grants the UPW's Motion to Extend the Deadline and Hearing Date on Respondents' Motion for Summary Judgment in this matter.
