On October 10, 2011, Respondent UNIVERSITY OF HAWAII, State of Hawaii (University), by and through its counsel, filed a Motion to Extend Time to Answer or Otherwise Respond to Complaint Filed on September 28, 2011 with the Hawaii Labor Relations Board (Board). The University requested an extension of the deadline to answer or otherwise respond to Complainant's Prohibited Practice Complaint filed on or about September 28, 2011 (Complaint). Respondent's counsel stated in a Declaration, dated October 10, 2011, *inter alia*, that individuals with knowledge regarding the background facts giving rise to the Complaint were out of town the week of October 3, 2011 and were not available until the week of October 10, 2011; the parties are currently engaged in discussions with regards to the matter that is the subject of the Complaint in an attempt to reach a resolution; and that she called Complainant's counsel who did not object to granting an extension of time to Friday, October 21, 2011, to answer or otherwise respond to the Complaint.

Based upon the foregoing, the Board finds good cause to grant Respondent's motion to extend the time to answer or otherwise respond to the Complaint, filed on September 28, 2011, to October 21, 2011.
