By letter dated June 29, 2012, Chief Negotiator Neil Dietz, on behalf of Employers advised the Exclusive Representative and the Hawaii Labor Relations Board (Board) that Henry Kanda would serve as the Employer's representative on the arbitration panel for the forthcoming Unit 09 arbitration.



By letter dated September 17, 2012, HGEA's Executive Director Randy Perreira, advised the Board that the parties have selected Mr. Joe Henderson as the Neutral Arbitrator and Chairperson of the arbitration panel, from the list of arbitrators provided by the American Arbitration Association.


