ORDER GRANTING COMPLAINANT ILWU'S
MOTIONS TO CONSOLIDATE CASES; NOTICE OF
HEARING ON RESPONDENT MURRAYAIR, LIMITED'S
MOTIONS TO DISMISS FOR LACK OF JURISDICTION

On March 9, 1994, Respondent MURRAYAIR, LIMITED filed simultaneous motions to dismiss Case Nos. 94-2(CE) and 94-3(CE) for lack of jurisdiction. Respondent asserts that the Hawaii Labor Relations Board (Board) must dismiss the cases because the National Labor Relations Board has jurisdiction over Respondent and the cases are preempted by the provisions of the National Labor Relations Act. Thereafter, on March 15, 1994, Complainant

INTERNATIONAL LONGSHOREMEN'S AND WAREHOUSEMEN'S UNION, LOCAL 142, AFL-CIO (ILWU) filed memoranda in opposition to the motions to dismiss.


YOU ARE HEREBY NOTIFIED that the Board will conduct a hearing pursuant to § 377-9, Hawaii Revised Statutes (HRS), and its Administrative Rules on Respondent's motions to dismiss on March 30, 1994 at 9:30 a.m. in the Board's hearings room, Room 203, 550 Halekauwila Street, Honolulu, Hawaii.

On March 14, 1994, the ILWU filed simultaneous motions to consolidate the unfair labor practice complaints filed with the Board in Case Nos. 94-2(CE) and 94-3(CE). In both cases, the ILWU alleges that Respondent refused to bargain collectively in violation of § 377-6(4), HRS. Thereafter, on March 16, 1994, Respondent filed statements of no opposition to the ILWU's motions.

As the ILWU's complaints involve substantially the same parties and issues, the Board finds that consolidation of the proceedings would be conducive to the proper dispatch of business and the ends of justice and will not unduly delay the proceedings. Accordingly, the Board hereby grants the ILWU's motions to consolidate Case Nos. 94-2(CE) and 94-3(CE). The complaints and the proceedings thereon are hereby consolidated for disposition.


