ORDER APPROVING AMENDMENT TO STIPULATION OF PARTIES


On April 27, 1994, the above-named parties submitted a Stipulation To Declare Certain Employees Essential Workers, dated April 27, 1994, to the Hawaii Labor Relations Board (Board). The parties agree that the employees set forth in the stipulation, are essential workers pursuant to § 89-12, Hawaii Revised Statutes (HRS), and are therefore prohibited from participating in a strike against the above-named Petitioner.

The Board has reviewed the subject amendment to the stipulation and finds that the positions identified by the parties are essential to protect the health and safety of the public. Accordingly, pursuant to § 89-12, HRS, the Board hereby orders that the positions identified in the Stipulation To Declare Certain Employees Essential Workers, attached hereto as Exhibit A and incorporated by reference herein, are essential and are required to be staffed in order to avoid an imminent or present danger to the


health and safety of the public. The remaining provisions of the Order Approving Stipulation of Parties, dated April 17, 1994, remain in full force and effect.

STIPULATION TO DECLARE CERTAIN EMPLOYEES ESSENTIAL WORKERS

The HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME,
LOCAL 152, AFL-CIO, (hereinafter "HGEA"), and the COUNTY OF MAUI,
(hereinafter "COUNTY"), hereby stipulate and agree that the
following employee of the County, set forth in Exhibit "1",

attached hereto and made a part hereof, is an essential worker pursuant to §89-12, Hawaii Revised Statutes, and therefore is prohibited from participating in a strike against the County.

It is further agreed that Exhibit "A" of the Stipulation To Declare Certain Employees Essential Workers ("Stipulation") dated April 17, 1994, be amended to reflect the agreed upon status of certain workers as reflected in Exhibit "2", attached hereto and made a part hereof.


It is further agreed that the terms and conditions of the Stipulation are hereby incorporated by reference hereto.
