ORDER GRANTING COMPLAINANT'S MOTION TO AMEND
ANSWER; DEADLINE FOR FILING DISPOSITIVE MOTIONS

On June 17, 1994, Complainant CHARLES R. BUNCH (BUNCH) filed a Motion to Amended (sic) Complaint with the Hawaii Labor Relations Board. On June 24, 1994, Respondent HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO (HGEA) filed a Memorandum in Partial Opposition to Complainant Bunch's Motion to Amend Complaint. On July 5, 1994, Respondents COUNTY OF MAUI, et al., filed a Memorandum in Partial Opposition to Complainant's Motion to Amend Complaint.


At the prehearing conference held by telephone call on March 1, 1995, the Board set the matter for hearing on March 15, 1995. However, after reviewing the record in this case and the arguments and concerns of the parties, the Board finds sufficient basis to grant Complainant's motion without a hearing pursuant to Administrative Rules § 12-42-43. Complainant is directed to file a First Amended Complaint with the Board incorporating the changes submitted in the Complaint attached to his motion by March 15, 1995.

YOU ARE HEREBY NOTIFIED that the deadline for filing any dispositive motions with the Board is March 31, 1995. Thereafter, any responsive memoranda shall be filed with the Board by 4:30 p.m. on April 10, 1995.

The Board will hear arguments on any motions filed on April 20, 1995 at 9:00 a.m. at the Civil Defense Conference Room (Emergency Operating Center), Kalana O' Maui County Building, 1st Floor, 200 S. High Street, Wailuku, Maui.
