ORDER GRANTING HGEA/AFSCME, ET AL.'S MOTION TO CONTINUE HEARING

On April 3, 1995, Respondents HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO, et al. (collectively HGEA), by and through their attorney, filed Complainant (sic) HGEA/AFSCME, et al.'s Joinder in Motion of Respondents County of Maui, et al. to Extend Time to File Dispositive Motions with the Hawaii Labor Relations Board (Board). The HGEA joins the motion of Respondents COUNTY OF MAUI, et al. (collectively Employer) which was filed on March 29, 1995 to extend the time to file dispositive motions from March 31, 1995 to April 7, 1995. The HGEA also joins

the Employer's motion to extend the date upon which Complainant CHARLES R. BUNCH's reply is due from April 10, 1995 to April 17, 1995.

In Order No. 1173 dated March 29, 1995, the Board granted the Employer's motions to extend the dates to file dispositive motions and any replies thereto. Thus, the HGEA's motion is moot with respect to those matters.

However, the HGEA further moves to continue the presently scheduled hearing date and time from April 20, 1995 at 9:00 a.m. to May 4, 1995 at 10:00 a.m.


HGEA's counsel states in an affidavit filed in support of the motion that the requested continuance will allow the parties sufficient time to review the materials in preparation for the hearing on the respective motions. Counsel also indicates that all parties agree to continue the hearing date and time.

For good cause shown, the Board hereby grants the HGEA's motion to continue the hearing date and time.

YOU ARE HEREBY NOTIFIED that the Board will conduct a hearing on any motions filed by Respondents on May 4, 1995 at 10:00 a.m. at the Civil Defense Conference Room (Emergency Operating Center), Kalana O' Maui County Building, 1st Floor, 200 S. High Street, Wailuku, Maui.
