ORDER GRANTING PETITIONER'S MOTION TO
CONTINUE HEARING; THIRD NOTICE OF HEARING

On May 11, 1995, Petitioner UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO (UPW), by and through its attorney, filed Petitioner's Motion to Continue Hearing with the Hawaii Labor Relations Board (Board). Petitioner requested a continuance of the hearing presently scheduled for May 17, 1995. The affidavit of UPW's counsel attached to the motion indicates that counsel is currently involved in contract negotiations for bargaining units 01 and 10 and will be unavailable on May 17, 1995 to participate in the hearing in this matter as scheduled. UPW's counsel states that he agreed with counsel for Intervenor to continue the hearing to May 26, 1995 but was advised by a Board representative that it would not be able to accommodate such request. Thus, UPW requests a continuance to some other convenient date.

On May 15, 1995, counsel for Intervenor DEPARTMENT OF PARKS AND RECREATION, County of Hawaii (COUNTY) filed an Affidavit

in Opposition to Petitioner's Motion to Continue Hearing Filed on May 11, 1995. Counsel for COUNTY objects to the continuance of the hearing or in the alternative, requests that the hearing be continued to a date no later than June 9, 1995 due to the unavailability of witnesses because of the COUNTY's summer fun program.

After reviewing the record in this case, the Board hereby grants Petitioner's motion for continuance for good cause shown. The Board has explored with the parties alternate hearing dates prior to June 9, 1995 to accommodate the COUNTY's request but was unsuccessful in finding a mutually agreeable hearing date.

YOU ARE HEREBY NOTIFIED the Board will conduct a hearing on the subject petition on July 6, 1995 at 9:15 a.m. at the offices of the United Public Workers, Hawaii Division, 362 East Lanikaula Street, Hilo, Hawaii 96720.

Appropriate provisions of the notices issued on April 19, 1995 and April 27, 1995 remain applicable.
