ORDER GRANTING RESPONDENT COUNTY OF MAUI, ET AL.'S MOTION TO CONTINUE HEARING; THIRD NOTICE OF RESCHEDULED HEARING

On June 20, 1995, Respondent COUNTY OF MAUI, et al. (Maui County), by and through its attorneys, filed a motion to continue the hearing on Respondents' respective motions to dismiss or in the alternative, motions for summary judgment with the Hawaii Labor Relations Board (Board).
