ORDER GRANTING RESPONDENTS OSWALD K. STENDER AND EAST-WEST CENTER'S MOTION FOR LEAVE TO FILE SUPPLEMENTAL PLEADING

STENDER and EAST-WEST CENTER (collectively EAST-WEST CENTER), by and through their attorneys, filed a motion for leave to file supplemental pleading with the Hawaii Labor Relations Board (Board). Respondents moved the Board for an order permitting Respondents to file a pleading supplementing their Motion to Dismiss Complainant Saleem Ahmed's Complaint filed January 31, 1995 and Amended

Complaint filed May 22, 1995, which was filed with the Board on June 23, 1995.

Respondents' counsel states in an affidavit attached to the motion, that the Board previously ordered dispositive motions to be filed in this case by June 23, 1995. The Board further ordered any responses to the motions to be filed by July 3, 1995. On June 23, 1995, Respondents' counsel was informed that Complainant SALEEM AHMED (AHMED) elected to withdraw his complaint before the Hawaii Civil Rights Commission (HCRC) and take court Thus, the HCRC dismissed AHMED's complaint. action. Because of the timing of the withdrawal, Respondents were not able to address the dismissal of AHMED in their Motion to Dismiss. Therefore, Respondents request leave to file a pleading addressing the matter by June 30, 1995 or whatever date the Board deems appropriate.
